If any of your certifications are not listed with the Alliance you will be required to provide copies to the BLOMHA office. **A Vulnerable Sector Screening Police Clearance is valid for two seasons.** If you have a VSSPC (Police Clearance) dated before 2008, it is invalid. **A Vulnerable Sector Screening form is to be obtained and processed at the BLOMHA office.** The fee is \$15.00 payable by cash or cheque to BLOMHA.
