As an Assistant Coach or Team Manager you must have, at minimum, a valid Vulnerable Sector Screening Police Clearance (VSSPC) and Speak Out certification. As a Trainer you must have the same AND an up-to-date Level Trainer certification. If you do not meet these requirements and/or there is no proof of them on file, then the required documents must accompany this application. If any of your certifications are not listed with the Alliance you will be required to provide copies to the BLOMHA office. **A Vulnerable Sector Screening Police Clearance is valid for two seasons.** If you have a VSSPC (Police Clearance) dated before 2008, it is invalid. If your Trainer certification number begins with '09' it expires in August 2009 and you must re-certify before the season begins. **A Vulnerable Sector Screening form is to be obtained and processed at the BLOMHA office.** The fee is \$15.00 payable by cash or cheque to BLOMHA.
